6. Hamilton Airshed Study - CAH Representation - Discussion

- Hamilton Airshed Study identified by AQTF Report and supported by Council
- HIEA and Public Health Services (representing the City) are jointly funding the \$125K

project

- Golder and Associates is undertaking 14 to 16 months of work
- An advisory committee for the work is being formed with the following representatives:
 - o City (Public Health Services Sally Radisic)
 - o Industry (U.S. Steel Canada Katie Chan)
 - o Province (Ministry of Environment and Climate Change Geoffery Knapper)
 - o Community (Environment Hamilton Lynda Lukasik)

 - o Clean Air Hamilton
- Clean Air Hamilton Chair, Denis Corr has been approached to be representation on the advisory committee.
- Request of interest from other members of Clean Air Hamilton present to represent on committee. None shown.
- Clean Air Hamilton members accept Denis Corr as representative on the Advisory committee.

Updates:

7. Clean Air Hamilton "(E)valuation" – Reminder

- Value of Clean Air Hamilton members and work in the annual Clean Air Hamilton report
- Value was seen as low and suggested a two level process to better evaluate the work and member's time
 - The end goal of the exercise is to formulate an aggregate economic value which is hopefully, more accurate (than the current reported value of \$69,000) and reflective of the time, expertise and diversity of those involved and contributing to CAH, and ultimately, to validate the value of the organization as a whole both internally and externally. The new value will not only be more accurate but will assist organizational members in leveraging project funds and attract new members to CAH.
- Level 1) Individual level member's time and input
- Level 2) Value of structure UpwindDownwind, AQTF, Committees, Annual Report
- There will be both an individual and structural level of analysis.
- Level 2 is more complicated and needs further discussion
- Level 1 is the template that was circulated to members for responses
- Response has been 64% (14 organizations) or 2/3 of members
- Currently the total organizational membership is 22
- \$125K is value to date and increasing this value is aggregated and not broken down individually as submissions are received.
- Members recommend a 3 week deadline (by Oct 5, 2014) to submit final information with

- regards to individual level
- Marie will resend Powerpoint presentation for the second piece level request for information and discussion of value
- Encourage members to complete and submit to Marie McKeary.

Action item: Brian to send out template again to members and members to submit responses to E(valuation) survey to Marie McKeary with 3 week deadline (October 5, 2014).

- The "Lets Talk About the Weather" campaign in the community to engage and develop a community climate change plan has been launched. http://www.climatechangehamilton.ca/jointhe-conversation
- Plan and actions will look at preparing community for climate change impacts/risks as well as reductions of emission sources
- Steering Committee social, environmental and economic has been formed with 17 members focus. Committee has met twice now
- Looking at forming Task Groups now, encourage community to look at themes and join a taskgroup.
- Eight themes for Task Force groups formed Water and Natural Heritage, Infrastructure, Land Use and Built Form, Transportation, Local Economy and Business, Agricutture and Food, People and health, Awareness and Education to make recommendations for actions.
- Energy has also been added to the themes.

- In short term as three weeks, have members aware of outside applicants approach them and encourage them to apply (approaching CAH is champion for application)

- Recommend best projects that fit Clean Air Hamilton strategic plan and activities be submitted air quality and climate change
- For longer process and 2016 projects need to:
- Standardization of process discussion, scoring matrix, panel presentation
- Objectives/criteria community awareness, actual reductions
- Document process going forward
- Suggestion that this be backed up to June meetings for 2016 projects with regards to future years so any large projects can seek capital budget of City
