- Drafting a draft action plan with recommendations
- Aim to have a draft report with recommendations to Clean Air Hamilton by July 2013
- Wish to have final report to Board of Health by November 2013
- 4 themes have emerged to date:
- 1) Control Actions
 - PM By-law
 - Street Cleaning
 - Active modes of transportation
- 2) Air Monitoring and Modelling
 - Airshed Model- Golders proposal
 - Increased Neighbourhood air monitoring
 - Do we have enough air monitors? Where should we have more?
- 3) Education and Outreach
 - PM Control Workshop
 - Expand school programming (idling, active transportation)
 - Community monitoring and reporting
- 4) Policy
- Planning (land-use)
- Dust control
- Matrix to show short, medium and long-term actions and low, medium, high costs
- Financial costs for recommendations will be given
- Focus is on actions to reduce emissions
- Co-benefits of actions is improved health

- Suggest link themes to environmental outcomes, what gets improved if actions taken

- Have students figure best route to school for active transportation and health and avoid poor spots
- Staff and students have been very supportive and receptive to project
