- Started 3 years ago in Toronto
- Goal: Transition neighbourhoods to carbon neutrality
- Work with neighbourhoods at the neighbourhood level
- Engaged 1000 households
- PN recognised for Climate Change Leadership, received Trillium Grant to expand
- What does PN offer?
 - Track emissions at household, neighbourhood and City-Wide level
 - Framework for engagement
 - Online tools to start the conversation
 - Leverage experience in T.O and investment tools

4. Upwind Downwind Conference – Brian Montgomery

- 160 attended conference, 140 attended Sunday talk
- 19 evaluations submitted Very Satisfied
- Presentations are posted online Sending out email
- Budget ballpark cost: \$32,000, brought in \$25,400. \$6,000 out of reserve fund

- Will require updates to Clean Air Hamilton as identified programs rolling out
- Some programs described:

A) Air Monitoring & Cyclists

- Program began in Pennsylvania
- bike based air monitoring program http://gasp-pgh.org/projects/bam/
- focussed on transportation corridors
- PM personal air monitor that cyclists wears
- Data extracted and then mapped
- City has some pedestrian monitors, may be of interest to have air monitoring coincide at those locations for pedestrians
- Suggestion that also look at strollers and children's exposure to air pollutants in transportation corridors.

B) Air Monitoring Schools
