8. Clean Air Hamilton Decision-Making

- Decision-Making group shared results with Clean Air Hamilton of work in August with recommendations.
- Members asked to review recommendations of group
- Recommendation was workshop with group once Chair found
- What is needed? How do we reach consensus? 100% or not 100%?
- Diversity of views and project support at table
- What is process of discussion and decisions?
- Agreement to a process to reach a decision
- Current Terms of Reference has consensus but what does that mean?
- Majority rules is not consensus but is an agreement model
- Changes to Terms of Reference to accommodate
- Minutes change to reflect decisions
- Agenda change to incorporate items as Information, Discussion and Decisions
- Each has a different process to come to Clean Air Hamilton and at meetings
- Always been a flexible group and information sharing
- Nature of group and multi-stakeholders
- Value in discussions at meetings
- Advisory group
- Ability to make decisions of group and individual members what is group going to do? and what am I going to do as a member?
- What if one wished to opt out?
- Recommendations of group versus advice by group?
- What is your position? If no position go back to group
- No agreement or abstain as a member, no process to identify this

- Record in minutes
- Advocacy versus advice
- Have discussion and clarify boundaries
- I fit goes beyond boundaries of group
- Clarification and confirmation of mandate
- Drive it to consensus
- Privilege of memberships can be lost if no support
- Positive side support member group in actions outside Clean Air Hamilton
- Some members can vote, other cannot = majority rules?
- Wait until we have a new Chair and set up a workshop
- Chair needs to be part of conversation
- Recommend having a workshop on decision-making when new Chair is found.
