3. Our Future Hamilton- Information – Heather Donison

- Update on Our Future Hamilton
- Request input from Clean Air Hamilton
- Vision 2020 was created back in the 90s
- Based on principles of sustainability
- Vision of the year 2020 for Hamilton
- Near end of cycle
- Need to look at next 25 years, what is new vision of Hamilton?
- Corporate Strategic Plan also ends at 2015
- Needs to draw from community
- Public Engagement Charter
- 40 citizens, eight principles of public engagement
- Went out to community in April (Phase 1) asking what your vision of the future of Hamilton?
- Just going into Phase 2
- Phase 3 will be in Jan 2016 and look at implementation of the draft visions
- Clean Air Hamilton has a role in implementation
- Need to revitalize that relationship
- Results to date of engagement relating to air quality were shared
- More efficient transportation system
- What is next for industry?
- Maintain and protect natural space and trees
- Reduce urban sprawl
- Stormwater and adaptable infrastructure
- Does not seem to be a connection between health and air quality
- Requests feedback from members

Denis C – Aligns exactly with items we have been talking about

- Update is timely
- more walkable, connected bike lanes
- intensification/mix use in the area of steel mills (if they go)
- extra lane to separate ebikes

Joachim – Interested in climate change, what should we be doing to address?

George M-Back in the 90s with the original Vision 2020, City staff of the Region produced background material and insightful analysis, is this occurring?

Answer – In Phase 2 info sheets will be provided

Karen L – Premature to talk demise of steel and steel lands

- Loss of tax base if occurs

Sally R – opportunity for Public Health to highlight the connections of health and air quality

Peter C – 30 speed limits in North End are great, should be more of this across City of Hamilton

Christine N – wondering if we have come to point that the linkages are given?

- presents opportunities to test the understanding in community
- Bayfront lands are top of mind due to media coverage
- Still industry is viable area and may need to transition to cleaner industry in future

Christine M – surprised about health and air quality linkages not mentioned

- opportunity for education and examine current communication methods
- needs to be explored more

Brian J – Hamilton is a great transit hub

- integration at municipal systems
- increase pedestrian mall downtown

Marie M – passed

Jayne C - does transportation include Go Transit?

- Inter-municipal transit and better Go Transit integration

Andy S – Huge improvements since Vision2020 by industry

- But there are still dirty and cleaner industries
- Need to improve work on reducing Particulate Matter emissions

Lynda L – Surprised by industry responses

- New people moving into City and comparing where they came from to Hamilton
- Question emissions in their neighbourhoods
- Should connect with neighbourhood hubs

- Peter T urbanist movement is growing, interest in transportation and parks
 - system approach thinking people are more focussed on individual modes
 - they like cycling, they hate transit
 - Need to understand linkages
 - Are answers being coded and ranked?

Answer – attempting that with data

- Brian M Not surprised by climate change responses
 - same found with community Climate Change Plan
 - energy and stormwater concerns and interest.

Denis C – House affordability – you can live like a human being in Hamilton

4. Transportation Demand Management in Hamilton – Peter T

- It's all about sustainability mobility
- Bike share and Car share
- Need to emphasis on connecting modes of transportation

Questions/comments:

- Marie M How are you collecting the data?
 - Are people aware that you are collecting data
- Answer Trip data is from GPS on bike
 - Frequency is from personal survey
 - Gender is from system sign up by name
- Brian J Cannon Bike lanes are good use of space
 - Look at convenience and electric assist bikes
- Denis C Economic argument is solid
 - Great for tourism
 - need to invest in transportation in Hamilton

5. Particulate Matter from Construction Areas – Discussion – Lynda Lukasik

- PM sources in construction
- Low hanging fruit sources
- Lynda presented pictures of dust emissions from sites (visible dust)
- Has recorded values using dust air monitor
- Recommendation of AQ Taskforce on Dust Workshops
- Env Hamilton has a Dust Buster program
- Encourage public to go to talk to contractors when they see these dust emissions

- Contractors to City are not using controls, but indicated to do so in contracts
- Suggest perhaps more specific wording in contracts
- Workers on site are unprotected Labour relate disuse of health and safety
- Request that we do dust workshops on construction areas including contractors in winter 2015/2016

Ouestions/comments:

- Karen L Have worked with Public Health services on site control in past
 - Ministry of Environment with Hamilton Industrial Environmental Association had a dust abatement workshop for industry, there is need for a workshop with contractors
- Andy S US Steel Canada has clause in Health and Safety in their contracts
 - sit down with contractors and discuss the mitigation of dust and personal protection of workers/contractors
 - project manager responsible for contract and watching contractors, actions of contractor recorded
 - if fail to manage dust, recorded in procurement and influences if contractor will be procured again in future.
- James K Dust control by-law needed
 - Raised this 2 years ago with group
 - a dust control plan needed for any earth works projects
 - Need to talk with City's Building Department
- George M– A lot of project management is involved in this in cities
 - Is no one watching the contractors in the field?
- Brian J— Provincial Regulations 419 Environmental and Reg 419 Health and Safety would look at some of this
- Denis C Workshop is needed
 - Include health and safety aspect, MOECC and by-law officer?
- Recommend subcommittee be formed to examine issue: Lynda Lukasik, James Kespertaz, Andy sebyestan, Karen Logan, Denis Corr,
- Suggest a representative from Public Works and Planning Building Department
