- Forest Ontario backbone organization of group along with several other important partners
- Scientific research includes the Toronto Public Health, 2015 and David Suzuki Foundation,

- Canadian Medical Association estimates number of premature deaths due to chronic exposure to air pollution expected to rise to 83% between 2008-2031

- Urban forest and density of tree cover very important. Example study in Portland Oregon showed 15% reduction in local NO<sub>2</sub>
- Study of effectiveness of street trees as barrier showed 50% reduction in measured PM levels inside houses. Complex relationship with selection of proper tree species to ensure positive net impact
- EcoHealth toolkit intended to communicate, showcase and promote. Collaborative process several multi-disciplinary stakeholders
- Chapter 1 of toolkit includes greenspace and health outcomes, benefits of greenspace etc.
- Chapter 2 draws connections between greenspace and health
- Chapter 3 includes municipal planning tools, public health tools (climate change and health vulnerability and adaptation assessment)
- Chapter 4 discusses case studies include York Region, Brampton, Simcoe Muskoka Health Unit
- Playbook section of toolkit provides guidance to the design and implementation of an Ecohealth campaign
- Lessons learned: need more assessment about effectiveness of policy and programs, along with several other lessons

## Questions/Discussions:

- Brian J. Asking if monitoring before and after benefits and if EcoHealth recommends indicators for monitoring?
  - Mike P. Good questions, next phase of toolkit is to build in business case. Include tree science of street trees similar to itree. Existing research on removal of Emerald Ash and the measured impact on health.
- George M. Emerald Ash Borer (EAB) research completed in 2013, was included in OPPI article, article was state wide.
- Karen L. Presentation available online?
  - o Mike P. Will send information to Trevor for distribution.
- Lynda L. Currently local tree group called *Air & Trees Task Force*. Partnership between NGO's and city staff with objectives of tree planting and tracking tree inventory for the improvement of air pollutants across Hamilton.
  - Mike P. Great local work being done, Peel Region recently created a GIS based powerful planning tool for priority tree planting across Region.
- Karen L. HIEA spent years working with MNRF on studying soils and working with the Marxan model to improve tree canopy across the Region.
- Denis C. City of Hamilton Forestry Department currently offering free trees to people.
- Karen L. Biggest challenge was the quality of the soil. Would plant a lot of trees and would die.

- Trevor I. Really great toolkit, locally in Hamilton the City is committed moving towards
  continuous improvement and using indicators as measurements. No indicator is going to be
  perfect but if Ecohealth ON research indicators and provided recommendations to
  municipalities on what indicators to track and how to do so would be very useful.
- Denis C. Local project called DASH-MASH that proposes super active transportation network across all of Hamilton. With help from Dr. Adams doing GIS spatial analysis discovered 93% already existed. Interested in EcoHealth's policy framework. Presented idea to Board of Health and Councillor Green very interested.
  - Mike P. Sounds like a great project, through research of case studies found having political champions very important.
- George M. University of Guelph students researching effectiveness of agricultural policies in ON. Found each municipality collecting stats data none of them really useful. More effective to monitor implementation.

# 5. GHG Inventory Report Board of Health Meeting October 16 2017 – Trevor Imhoff (10 minutes)

- Completed BOH report on 2015 GHG inventory and actions on climate change in Hamilton. Report and presentation to BOH on October 16, 2017 at 1:30PM.
- Industrial emissions continue to be Hamilton's largest source of emissions. Excluding industrial and steel emissions transportation emissions are largest source of emissions.
- Using Statistics Canada vehicle registration data and fuel consumption data broke down
  emissions by vehicle class. Light duty vehicles make up approximately 75.8% of transportation
  related emissions. Transportation also the only sector that has not experienced any GHG
  emission reductions.

# 6. Upwind Downwind 2018 Update – UWDW Planning Sub-Committee (10 minutes)

- Trevor I. UWDW planning committee continues to work out the details of the conference. All invitations have been sent out to speakers. MOECC Standards Development Branch have confirmed their attendance for cumulative emissions modeling.
