3. Academic Sustainability Programs Office, McMaster University Presentation – Kate Whalen, Senior Manager & Abbie Little, Office Coordinator (15 Minutes)

Link to Presentation:

- Office is meant to inspire all students a desire for continued learning and inquiry through experiential learning
- Provide interdisciplinary, student-led, community-based and experiential education
- Offers Sustainability Internship Program, GUCEL Program, generally 4 or 8 month duration
- Example project included fourth-year Science student creating design for McMaster Outdoor Learning Space, successful obtaining \$28k in grant funding and facility implemented student's design

- GUCEL Program (Graduate/Undergraduate Collaboration in Experiential Learning): opportunity for Grad students to work in collaboration with Undergrads.
- Other example of projects include group projects creating toolkit outlining steps for great accessibility for transportation and a report toolkit for a flourishing lifestyle for the ageing community

# 5. 2017 MOECC Air Quality Progress and Trends – Trevor Imhoff (10 minutes)

- This is a DRAFT for discussion purpose only. Have not yet been confirmed
- Overall trends majority of pollutants continue the decrease trend including: Total Suspended Particulate (TSP), Inhalable Particulate PM<sub>10</sub>), Ozone, Benzene and Benzo(a)pyrene.
- Note for Benzene and Benzo(a)pyrene for the Downtown (City) monitoring site there has been no data since 2015. Will ask the Ministry if that data available.
- PM<sub>2.5</sub> appeared to slightly increase between 2016 & 2017, SO<sub>2</sub> also appears to have increased the past two years (2016/2017) at Downtown (City) site as well as for 2017 for 1 Industry Site.

Questions/Discussions:

- James K. Do we know why? What causes some pollutants to increase and others decrease? Is it local changes/variations?
- Trevor I. Unsure of why. Perhaps future sub-regional analysis for airshed modelling would help find out?
- Trevor I. Asking MOECC if there are other cities that conduct SO<sub>2</sub> monitoring that we can compare Hamilton to in future graphs?
  - Dan D. Sarnia has SO<sub>2</sub> monitoring, we provide previously request graphs
- Trevor I. OK in the future we can work to get that information. Also wondering about if we can expect Benzene data for 2016/2017
  - Dan D. Environment and Climate Change Canada does analysis so out of our control.

## **Updates:**

- 6. Hamilton Airshed Modelling System (HAMS) and Sub-Regional Analysis Proposal - Trevor Imhoff (10 minutes)
  - Trevor I. presented re-cap of HAMS results including tiers and pollutant source contribution.
  - Trevor I. also presented recommendation from previous Board of Health (BOH) report including but not limited to recommendations of:
    - That sub-region analysis of the HAMS be performed,
    - Examine feasibility of using HAMS to estimate morbidity and mortality outcomes; and
    - That PHS staff work with Planning Staff to review HAMS analysis and determine appropriate applications for planning directions and decisions.
  - Golder Associates has come back to PHS staff with a proposal to conduct subregional analysis by ward.

## Questions/Discussion:

- Lynda L. Asking why sub-regional analysis by ward?
  - Trevor I. Believe staff specifically asked for this, reasoning was to gain more political attention by doing by ward. Unsure if we want to make it political and airshed does not follow ward boundaries.
- James K. Make it political as soon as you do it by ward
- John L. Asking if any sense of sources from transboundary? Ex. Transportation, industry etc.?
  - Trevor I. Unsure if transboundary sources have been source proportioned, however agree it would be helpful moving forward to start having that discussion with our provincial/federal partners.

# 7. 2017 Clean Air Hamilton Progress Report to BOH Update – Trevor Imhoff ( 5 minutes)

- Briefly presented rough draft of CAH 2017 Progress Report.
- Included projects from Green Venture and Corr Research for their Enhanced Fresh Air for Kids projects and Environment Hamilton's Particulate Matter Building Workshops.
- Due to unforeseen staff transitions and new change in Provincial Government need to delay BOH presentation and report.
- Trevor I. asking CAH members when should delay report to.

## Questions/Discussion:

- Karen L. Agrees, in the past it was always rushing to get complete for July presentation. Would recommend delaying it to September for future years.
- 8. GRIDS 2 Comprehensive Municipal Review Update Trevor Imhoff (5 minutes)

  - Overall GRIDS 2 is a future plan on how to plan our built environment across the city including job growth, infrastructure, transportation modes etc.

- Trevor I. Recommending having a Planning Staff working on the project to come present more information to CAH
  - Group agrees
- Lynda L. This is important for CAH air quality work
- George M. Recommend looking deeper into integrity of airshed model into these types of plans, also focusing on O.Reg 419, Cumulative Effects Assessment and how it can all work better together.
- Matt A. Asking how well did Hamilton do in first round of GRIDS
  - Lynda L. City issued report that detailed city struggled to meet targets. Interesting GIS mapping including. Will send to Trevor for distribution to group
