3. Use of Low-Cost Sensors for Ambient Monitoring: A Consultants Perspective (20 minutes), Hemmera, Lucas Neil

- Hemmera has main offices in Burnaby and Oakville, satellite offices throughout Canada, one in Hamilton,
- Projects throughout the country using low cost sensors,
- Project on Air Pollution at Local Schools, looking at air pollution at schools in Kitchener,
- Monitors how idling vehicles impacts air pollution between summer and during the school year to find difference,
- Another project in Alberta near a construction site monitoring TSP and PM_{2.5},
- Project will allow for mitigating,
- Landfill Monitoring Project,
- Monitoring TSP, PM₁₀ and PM_{2.5},
- Transportation Terminal has requested collection data on nearby communities,
- Network Augmentation, Identification of On-Site Activities and Corporate Accountability.

Questions/Discussion

- .9 AQMesh monitoring correlation.
- Cost \$10-15k US, Sentroid \$20-30k and can be built to spec,
- Benzene and BAP they haven't monitored in Ontario, but may have out West, low cost hasn't been done, but higher cost can be done,
- Community groups could collaborate for funding,
- Hemmera is working with the schools on educational component in School Drop Off Areas.
- Hemmera is not familiar with Fresh Air For Kids, but will look at literature,
- Suggested that Hemmera's colleagues contact Green Venture to learn more about Fresh Air For Kids,
- Natalie S to follow up about data with Lucas N on Kitchener data collection,
- Some particulates might not look the same as USEPA method, asking about accuracy of PM_{2.5} and PM₁₀. These can be fussier than chemicals.
- Hemmera looks at project goals and uses a system that will work for what data they are looking to collect.

4. Bike Share, (15 minutes), Chelsea Cox, Hamilton Bike Share



- Hamilton was an early leader for Bike Share,
- 800 smart-bikes.
- Looking to continue Strong Service Levels, Financial Sustainability and Long-Term Infrastructure,
- Ultimate Goal: A more livable Hamilton.

Questions/Discussion

- Concern of sustainability of the share from members,
- Bike Share programs vary from city to city, most cities that are growing are receiving funding through the municipal government, in the US it can be State or Federal. In BC municipal and user fees,
- Members believe that the City of Hamilton should be providing funding for Bike Share, importance for modal shift,
- Members ask how CAH support Bike Share? They would love CAH support. This will be an ongoing conversation, helping political leaders to know more about the value of the system. It has been complicated, sharing the benefits to all citizens, funding is a huge key,
- Council has discussed Suburbs vs. Downtown, can it be expanded if they had more funding, this might engage those councillors more. Without more funding, the service can't grow. Feasibility studies would have to occur, and that would require funding. They want to expand, but can't without a financial model. Bike lanes being added will make it better.

Tire Fire site remediation is moving along. They are hoping to use the material as blast furnace material at a local steel company. Rotek is involved with Pearson Airport, they have moved two of the mobile trailers indoors in the Airport Terminals. They tried to change the AQHI colours, Denis is working on correcting this. Looking on what to do at Martin Falls. They didn't want to put staff on planes the last few months, feeling more comfortable now. Things are busier than he thought.

Two issues 1. A resident in idea of relocating location of mobile air monitors, wanted to move them to Gage Park. 2. Some questions from citizens in industrial area around dust and drag out and if there is enforcement.

- 1. Andrea M Everyone is redeployed and there is a lack of resources to move the stations. It takes a few months of lead time to move the stations. Both are moved together to locations that aren't too far apart. The location has been put on the list for future moves, but there is no timeframe.
- 2. Trevor I will follow up with Kerry, prior to COVID, a PHI was providing reactive enforcement of this. Trevor I is looking into capacity of the PHI working on this.
