This land is covered by the Dish With One Spoon Wampum Belt Covenant, which was an agreement between the Haudenosaunee and Anishinaabek to share and care for the resources around the Great Lakes. We further acknowledge that this land is covered by the Between the Lakes Purchase, 1792, between the Crown and the Mississaugas of the Credit First Nation.

Today, the City of Hamilton is home to many Indigenous people from across Turtle Island (North America) and we recognize that we must do more to learn about the rich history of this land so that we can better understand our roles as residents, neighbours, partners and caretakers (source).

## 3. Health Impacts of Air Pollution in Canada (20 minutes) Mathieu Rouleau, Health Canada

- Question: Is there an incoming standard from Health Canada for Ultrafine Particulates?
  - Ultrafine particulates are a priority pollutant for Health Canada. However, there is a lack of historical data. There is a need to build up the data.
  - There are three ultrafine particulate monitoring stations in Canada at this time
- Question: Are there any additional pollutants that will be added to the AQBAT model?
  - At this time, the focus is on adding health effects to AQBAT instead of adding additional pollutants
- Health Canada is able to generate city specific morbidity and mortality information if requested.
